ANNUAL REPORT ON ANTI-RAGGING AND SEXUAL HARASSMENT CELL 2020-21

The Anti-Ragging and Sexual Harassment Prevention Committees at Sree Narayana Nursing College, stonehousepet, Chinthareddypalem have actively worked throughout the year to ensure a safe and inclusive campus environment. A series of awareness programs, workshops, and interactive sessions were organized to educate students and staff about UGC anti-ragging regulations and the legal framework for preventing sexual harassment, emphasizing the consequences of non-compliance. The Anti-Ragging Committee conducted frequent inspections of hostels, classrooms, and common areas, resulting in no reported incidents of ragging this year. Similarly, the Internal Complaints Committee (ICC) efficiently addressed minor sexual harassment complaints and provided timely, confidential resolutions. Confidential reporting systems were established, enabling victims to report incidents without fear of retaliation, which increased student confidence in the system.

Regular feedback from students was collected and analysed to refine preventive strategies and improve intervention measures, ensuring that the campus remains a secure environment for all. The committees also worked closely with hostel wardens to monitor sensitive areas around the clock and assigned peer mentors to help new students adjust to campus life. Collaborative efforts with external legal experts, counsellors, and local law enforcement enhanced the support network available to students. Additional measures included the integration of anti-ragging and sexual harassment education into the curriculum and the creation of a dedicated helpline for immediate assistance. Looking ahead, the committees plan to enhance the anonymous reporting mechanism, organize additional awareness initiatives, and further solidify the institution's zero-tolerance stance on ragging and harassment, strengthening the overall campus safety framework and fostering a more inclusive academic community.
